Transferable Warranty

Coverage & Duration

UVX Universal Vinyl Extruders, Inc. warrants that its vinyl product line is free from defective workmanship and materials. UVX warrants its products against peeling. flaking, blistering, splitting, rot or abnormal weathering and abnormal discoloration under conditions of normal use and service. Color change due to weathering that is even and equal when exposed to the same sunlight and environmental conditions is excluded from the warranty because typical weathering will cause any colored surface to gradually lighten, chalk or accumulate dirt or stains. The severity of these conditions depends on the geographic location and surrounding air quality and other local conditions, which UVX has no control over. UVX Universal Vinvl Extruders. Inc. warrants only those products produced by UVX Universal Vinyl Extruders, Inc. itself. UVX shall not be responsible for any costs associated with the removal of the original vinyl product. This warranty will be void if UVX products have been mixed with profiles not fabricated by UVX Universal Vinyl Extruders, Inc. This warranty extends only to the original purchaser unless the warranty is transferred according to the terms specified herein. The coverage of the UVX lifetime warranty is specifically intended to apply to individual homeowners exclusively. In the event of UVX vinyl products being purchased and installed by property owned by corporations, government agencies, public buildings such as schools or libraries, or co-operative housing such as gated communities or townhouses or any type of premise not used by the individual homeowner, the warranty shall be 30 years following the installation of the UVX product. This warranty does not cover the cost of installation of any defective products or the cost of installation of any replacement product furnished under the terms of the warranty. It shall be noted that UVX Universal Vinyl Extruders, Inc. and its employees are not qualified to approve, recommend or advise as to the safety of the intended use of any UVX product. Consult you local authority as to the safety of its intended use.

Limitations

The coverage listed above does not apply to any failure, defect or damage resulting from or connected with the following:

- Accidents, altered finish, misuse, improper applications such as product being treated with chemicals, unless approved by UVX Universal Vinyl Extruders Inc., or the improper installation of hardware, gate or accessory items, including the use of implements or tools that are not recommended for normal installation
- Any act of God such as tornados, hurricanes, ground movement, and/ or other violent storms or impacts caused by the above mentioned natural disasters.
- 3) Fire, air pollutants, normal weathering of surface discoloration, improper installation or machinery coming in contact with material.
- Damage from foreign objects, improper handling of the product or improper solvents or maintenance not recommended by UVX Universal Vinyl Extruders, Inc.

Reporting Defects & Resolving Discrepancies

All defects or failure of product must be brought to the immediate attention of UVX Universal Vinyl Extruders, Inc. All questions pertaining to the validity of this agreement shall be resolved in accordance with New York State Law. UVX shall be the sole judge of whether or not the product is defective and whether the defect is due to manufacturing. Based upon UVX determination of the claim, the section or part of the product will either be replaced or a refund shall be issued at the prevailing cost of the section or part at the time of replacement or the original pro-rated price, whichever shall be less.

How to Transfer Warranty

This warranty is transferable by the original property owner to the subsequent property owner on a pro-rated basis from the original purchase date. UVX must receive a written request of transfer, proof of the original purchase, and \$100 transfer fee payable to UVX Universal Vinyl Extruders Inc. within (60) days from the date of real estate title transfer. Failure to request the warranty transfer to the new owner and pay the specified transfer fee shall relieve UVX of any further obligation under this warranty. Only in the event of transfer of the warranty as provided above, the warranty period will be prorated as follows: During the first ten years, UVX will, at its option, replace the product or refund the original cost of material based on UVX's list price at the date of purchase. Thereafter, every five years UVX's responsibility will decrease by 10% of the original cost of the material based on UVX's list price at the date of original cost for the remaining warranty period. Under no circumstances will UVX be liable for the removal or installation of replacement product.

Cleaning & Maintenance

*Vinyl Fencing is the most maintenance-free product on the market today; however just as with any other product exposed to the outdoors, it will become soiled over time. A heavy rain or washing the product with a garden hose may be all that is needed.

Use a soft cloth or brush with soft bristles for the following types of stains.

- Oil, greases, wax, crayon, or tars: Use solvents such as mineral spirits, V.M.P. naphtha or auto tar remover. Remove excess with plastic or wood scraper.
- Ink, nail polish, paint, lipstick, gum etc: Use cleaning fluid such as trichloroethylene. Remove excess with plastic or wood scraper.
- 3) Tough stains: Use Xylene or lacquer thinner. Dampen small section of cloth with lacquer thinner and rub vigorously.

For light stains use Simple Green[©] or Soft Scrub[©] with soft cloth. * References to proprietary names are used for illustration purposes only. There are similar products on the market that will be as effective.
